

In the interest of public service and in compliance with Section 1301 of the National Building Code (PD 1096), Republic Act 184 (Amended by RA 7920), the Electrical Engineering Law, and the Philippine Electrical Code (PEC) and as per letter of the Professional Regulatory Board of Electrical Engineering, you are all hereby directed to be stricter in approving Building and Construction Permits by requiring the submission of electrical plans that includes design analysis showing all the calculations of short circuits and voltage drop and other necessary data as a requisite for the issuance of the aforementioned permits.

Further, all existing buildings, factories and infrastructures with substantial electrical loads be subjected to inspections and that an updated design analysis and calculations be required to ensure that fire and life safety requirements are being complied with.

This will be strictly imposed to prevent incidents of fire.



REGULAR CONTRACTOR'S LICENSE



ELECTRICAL PERMIT **ADDITIONAL REQUIREMENT - PCAB** (Philippine Contractors Accreditation Board) license will be required should the project electrical designed installation capacity is 200 Amperes and above. PCAB license must indicate that it is intended for electrical works.

DOCUMENTARY REQUIREMENTS FOR OCCUPANCY PERMIT

Upon completion of the building/structure, an Occupancy Permit must be secure prior to occupying or use of the building/structure. Occupancy Permit application is done online thru www.puertoprincesa.ph. Documents will be printed as output of the application and will be for signature of professional involved with the construction/project.

As part of application for Occupancy Permit for Electrical, the following will be attached and must be submitted together with the other documents :


1. Approved Electrical Permit

2. Approved Electrical Plan

3. An accomplished Certificate of Final Electrical Inspection form.

 Photo copy of Valid PRC ID and PTR of the Electrical Professionals Involved with the construction/project.

5. Photos of Open panel board showing breaker ratings, service entrance, transformer and etc.

OTHER REQUIREMENTS

Additional requirements will be required, depending upon technical evaluation and outcome of site inspection. Below are the common additional requirements :

 As-built Electrical Plan – if upon inspection, it was found out that the installation was not in accordance with the Approved Electrical Plan.

2. PCAB for occupancy – if the MDP (Main Distribution Panel) capacity of the Electrical System is 200 Amperes and above.

3. If As-built Electrical Plan was required, An Electrical Design Analysis must be submitted if the circuit Main Breaker of the electrical system above 70 Amperes or if it has 2 or more Panel Board.

If the electrical work or installation is found not in conformity with the minimum safety requirements provided by the Building Official, the latter and/or their duly authorized representative shall forthwith cancel the permit and the fees thereon shall be forfeited.
